

- [ii] The recurring expenditure for District Child Protection Society [DCPS] has been provided for the two months of the financial year. Non-recurring expenditure for purchase of furniture, equipments, etc. has been allowed in the current financial year of 2009-10
- [iii] No fund is allowed for setting up of new open shelters in the current financial year of 2009-10.
- [iv] The grants-in-aid to the 5 Homes [1 Children Home, 2Special Homes and 2 After Care Homes] being run by NGOs which were getting financial assistance under the erstwhile scheme namely 'A Programme for Juvenile Justice' has been allowed as per the norms of the erstwhile scheme, 'A Programme for Juvenile Justice' in the current financial year. The old norms have been proposed keeping in mind that these projects are still running as per the specifications of erstwhile Juvenile Justice scheme and would require some time to upgrade themselves to the criterion laid down under ICPS. No funds for construction/ maintenance of additional homes have been allowed during the current financial year of 2009-10.
- [v] The grants-in-aid to the 8 Homes [1 Children Home and 7 Observation Homes] being run by State Government which were getting financial assistance under the erstwhile scheme namely 'A Programme for Juvenile Justice' has been allowed as per the norms of the erstwhile scheme, 'A Programme for Juvenile Justice' in the current financial year. The old norms have been proposed keeping in mind that these projects are still running as per the specifications of erstwhile Juvenile Justice scheme and would require some time to upgrade themselves to the criterion laid down under ICPS. No funds for construction/ maintenance of additional homes have been allowed during the current financial year of 2009-10.
- [vi] The recurring expenditure for 16 Child Welfare Committees [CWCs] has been allowed for three months of the current financial year only. The non-recurring expenditure for purchase of furniture, equipments, etc. has been allowed in the current financial year of 2009-10. No fund for construction of mew building/room for CWCs is allowed during the current financial year 2009-10.
