Subject: Central share of grants-in-aid to the Government of Manipur under the scheme namely 'Integrated Child Protection Scheme' (ICPS) for the current financial year 2009-10.

Sir,

I am directed to convey the sanction of the President to the grants-in-aid of **Rs.1,05,42,333/- (Rupees One Crore Five Lakhs Forty Two Thousand Three Hundred and Thirty Three only)** to the Government of Manipur as Central Share for the current financial year of 2009-10 under the Centrally Sponsored Scheme, namely, "Integrated Child Protection Scheme" as per details given below:

2. The above-mentioned grant is subject to the under mentioned conditions:-
- (i) The grant-in-aid to the 1 Open Shelter is allowed as per the norms of the erstwhile scheme 'An Integrated Programme for Street Children' during the current financial year of 2009-10. The State Government will release the amount shown against it only after this projects is visited by the State Government, who should satisfy themselves that this organization is running the project satisfactorily and is eligible for grants-in-aid.
 - (ii) The grant-in-aid for the existing 5 State Government run SAAs and 1 NGO run SAA for full year is allowed as per the old norms of the erstwhile scheme namely 'Scheme of Assistance to Homes for Children (Shishu Greh) to Promote In-Country Adoption'. The State Government will release the amount to the organization running the SAA shown against it only after this project is visited by the State Government, who should satisfy themselves that this organization is running the project satisfactorily and is eligible for grants-in-aid.
 - (iii) The grant-in-aid for the 12 Observation Homes/Children' Homes which were being run by NGO and were getting assistance under the erstwhile scheme namely 'A Programme for Juvenile Justice' has been allowed as per the norms of the erstwhile scheme in the current financial year. The old norms have been allowed keeping in mind that these projects are still running as per the specifications of erstwhile Juvenile Justice Scheme and would require some time to upgrade themselves to the criterion laid down under ICPS. No fund for construction/maintenance of additional homes is allowed during the current financial year of 2009-10.

- (iv) The grants-in-aid for the Child Welfare Committees [CWCs] and Juvenile Justice Boards [JJBs] have been allowed for four months and 25 days of the current financial year [i.e. 06.11.2009 to 31.03.2010]. However, no fund for construction of new building/room for CWCs and JJBs is allowed during the current financial year of 2009-10.
- (v) The State Government shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grant and submit the same to this Ministry immediately after the close of the current financial year 2009-10.
- (vi) The State Government should certify that the maintenance grant in respect of voluntary organizations are approved by the State Government as required under the Juvenile Justice (Care and protection of Children) Act, 2000.
- (vii) That no further grant will be released till the utilization certificate and the audited statements of accounts towards grant already released are furnished to this Ministry.

3. The above grant in aid will be released to the **Government of Manipur through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.**

4. The expenditure involved is debitable to Major Head 3601; Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare – Child Welfare; 07-Integrated Child Protection Scheme[ICPS]; 07.0031 – Grants-in-aid; Demand No.104, Ministry of Women and Child Development for the year 2009-10(Plan).

5. This issues with the concurrence of IF Division of this Ministry vide their Dy. No.1607/AS&FA/10 dated 10.02.2010.
